

- Our national debt is \$13.1 trillion (as of July 12, 10 AM) ([www.usdebtclock.org](http://www.usdebtclock.org))
- Our TOTAL debt is over \$54 trillion. ([www.usdebtclock.org](http://www.usdebtclock.org))
- Obamacare is adding 159 NEW government agencies ([ww.newsmax.com](http://ww.newsmax.com)).
- \$787 Billion Stimulus Bill passed with CBO estimating spending to kick-in in 2010 lowering unemployment to 6.8%. Early January 2009, unemployment was at 7.2% ([www.forbes.com/2009](http://www.forbes.com/2009)). Today, it holds at 9.5%
- Anticipated additional government jobs from Stimulus Bill = over 200,000 in next three years ([www.monster.com](http://www.monster.com))
- \* Omnibus Spending Bill passed March 2009 = \$410 Billion and over 9,000 earmarks. ([www.heritage.org](http://www.heritage.org))
- The Financial Reform bill (over 2,000 pages) calls for 20 new federal diversity agencies, requires regulatory agencies to pass 350 new rules, conduct 47 studies, and issue 74 reports. - Government now controls over 90% of the mortgages in US (Freddie Mac and Fannie Mae)
- Government now controls 100% of student loans (in Healthcare bill).
- The top five employers in Chicago are all government entities. (Crain's; [www.NapervilleTEAPatriots.com](http://www.NapervilleTEAPatriots.com))
- In Illinois, there are 3,700 pensions in excess of \$100,000 and they are NOT TAXED at the state level. ([www.familytaxpayers.org](http://www.familytaxpayers.org))
